FROM THE LEAGUE . . .

The extended deadline for comments on the expansion of the HF telephony bands (FCC Docket 82-83) is August 16 -- just around the corner! Copies of this docket may be obtained by giving me a call (447-0542). The importance of this proceeding and of our input as concerned hams cannot be overemphasized.

Several hams have inquired about the fate of last year's Goldwater proposals. Well, they are alive and well, thank you, and proceeding (no pun intended) through the House at this time. The "Communications Technical Amendments Act of 1982" (H.R. 5008) came before the appropriate subcommittee in early May. Included are permission to use amateur volunteers in the preparing and administering licensing exams and in monitoring for (but not enforcing!) rules violations; authorization for the FCC to set minimum standards for audio and visual electronic equipment to reduce susceptibility to RFI; a proposal for ten-year station license terms; and an exempting hams from the secrecy provisions of Section 605 of the Communications Act. By now the bill should have been considered by the Committee on Energy and Commerce. We have no word on its fate at press time.

There is a strong push afoot to obtain Senate consent to ratify the WARC-79 treaty. At hearings before the Senate Foreign Relations Committee, the private sector was represented only by speakers from Motorola and ARRL. Several countries have already authorized the use of the 10-MHz band, and the League wants it approved for us, too. Unfortunately, a late request by Senator Schmitt (R-NM) may delay action. Time will tell!

At a meeting of FCC and League personnel in early May, substantial agreement was reached on the issues of monitoring, examinations, and license reciprocity. This last item is of concern with regard to Canada and Japan. Canadian rules limit a visitor to those privileges he or she enjoys at home, or Canadian privileges, whichever is the more restrictive. Simply stated, this now permits Novices and Technicians to operate in Canada but restricts some higher classes, especially in the telephony bands. In the case of Japan, consider the prospect of thousands of visiting hams, many of whom have never taken a Morse code test, operating in the U.S. Also, the cumbersome station inspection procedures in Japan can be a serious impediment to obtaining a reciprocal license there.

Three FCC actions worth noting: The deletion of R&R Section 97.71 requiring the licensee of a ham station operating below 144 MHz to use an "adequately filtered DC plate power supply" is an indication that the Commission recognizes our ability to police our hobby. Cited reasons included the easily detectable "hum" produced by a poorly filtered supply and the advanced state of the radio art. Also, the requirements of Section 97.74, requiring the regular measurement of emitted carrier frequency were deleted. Finally, (TAKE NOTE, ALL YOU ELMERS!) the return period for novice class exams has been extended from 30 to 60 days.

From the League . . . (Cont.)

You may recall the recent furor that raged through the ham radio community in Great Britain when the Home Office, the agency responsible for ham radio, released an unannounced new schedule of operating privileges, rife with errors and changes of major significance. The Home Office, in cooperation with the Radio Society of Great Britain, has adopted a new schedule resolving the problems and oversights. Perhaps as important, the working relationship of the two groups is reported to be much improved.

The whole incident points up the importance of a close relationship between the governing agency and the ham community. The ARRL has been an effective voice in Washington for many years and continues to work for all of us. When you hear criticism of the League, as we all have, weigh it against the alternative. If you now of a problem area, contact West Gulf Division Director Ray Wangler, W5EDZ, or one of the Assistant Directors in the Houston area and air it. This is your League; make it work for you.

Clive Sinclair, an Englishman, and still a comparatively young man in his early forties, for the last 20+ years has been about the business of developing and marketing by mail order and through multitudinous small retail outlets, a number of small-sized electronic devices, such as a match box radio, a pocket calculator, hi-fi amplifiers, and personal computers. His ZX-80 4-chip computer made him wealthy, and his ZX-81 model is selling at the rate of 50,000 a month and over half a million of them are in use. Development of his current pet projects is on schedule -- a 2" pocket TV and a low-cost battery-operated automobile. At age 35 he received the "Queen's Award to Industry", a prestigious award for technological innovation.

Now, he has dropped another bomb on the personal computer market. His brand-new ZX-81 Spectrum (not yet in this country but coming), a \$200 16K microcomputer, has a full calculator-type keyboard, fully "memory mapped" Z80A CPU, a real time clock, audio output, and a full-color display! He is currently seeking FCC approval of an RF modulator with which the computer is hooked to a TV antenna. Sinclair BASIC uses single keystrokes for all keywords and commands. All of the 256 X 192 pixels are directly addressable for full-color graphic capability. Size of the ZX Spectrum is 9"X5"X1"! A \$90 ZX microdrive (3" floppy disk) and RS-232 interface output will be available for it this year.

What about the \$100 ZX-81? Sinclair has turned its marketing ovef to Timex, and don't be surprised to see the Timex/Sinclair 1000 (2K expandable to 18K) start turning up in big Timex outlets by sometime in July.

If all that isn't enough to give ulcers to the nation's personal computer manufacturers, an announcement by Japan's Casio Computer Company will. They plan to introduce in Tokyo in about 60 days a personal computer to retail at \$63. It'll probably be only a matter of time before the PB100 reaches the U.S. Things happen so fast in the personal computer game that it's hard to keep track of the teams and players...much less the score!!!
