FCC AUTHORIZES VOLUNTEER AMATEUR EXAMS

From W5YI Report

In a landmark decision, the Commission has adopted a Report and Order establishing volunteer testing (both preparation and administration of exams) for Amateur Radio Operator licenses above the Novice Class level. This change will offset the limitations and opportunities for Amateurs to take the examinations that have resulted from funding and personnel cutbacks within the FCC.

The exams at present are administered by FCC personnel- usually at Field Operations Bureau offices. In some areas they are now given only once a year and the number of remote locations has been reduced.

Legislation (Public Law 97-259) signed into law by President Reagan on September 13, 1982 authorized the FCC to use licensed amateurs on a voluntary and uncompensated basis to prepare and administer amateur exams. Barry Goldwater, K7UGA, was basically the author (Senate Bill 929) of the amateur volunteer program.

The American Radio Relay League, an organization of amateur radio operators, proposed a plan for use of amateur examiners in a petition to the FCC in October of 1982. Under the program, individuals and organizations would propose questions for all examinations based on the FCC study guide for the Amateur Radio Operator Licence Examination. The FCC would then issue lists of approved questions which it will draw on for exams.

The Report and Order adopted September 22nd at the FCC Commissioners provides for written examinations to be administered by three person teams of examiners who will report to regional Volunteer Examiner Coordinators. (VEC) The VEC's will assist in an orderly flow of information to and from the Commission, coordinate the efforts of volunteer examiners and minimize the likelihood of fraud and abuse.

The big surprise is that the FCC departed from their original proposal and has decided to substitute regional VEC's for nationwide VEC's....
"to get a significant amount of partipation in this program."
The regions will coincide exactly with the present amateur licensing call sign districts. There will be thirteen districts - 1 through 0 plus the Pacific, Alaska and Atlantic (non-contiguous USA) areas.

The FCC is seeking groups to undertake volunteer examination coordination for each district. Ray Kowalski, FCC Chief, Special Services, Washington, DC, said that it is possible that one main regional VEC group could have sub-groups or clubs to assist them in carrying out their duties- particularly in large districts.

Specific qualifications to participate in the voluteer program are spelled out to avoid any conflicts of interest. Abandoned was the concept of an examining team chief although three volunteer examiners are required. All Morse Code tests and the Advanced and Extra Class exams must be given by a team consisting of Extra Class licensees. Element 3 (General and Technician Class Theory) can be administered by three Advanced Class amateur examiners.

FCC AUTHORIZES VOLUNTEER AMATEUR EXAMS (Cont.)

The mechanics of the new volunteer testing program involves a complete new sub-part of the rules. The Commission rules that no expenses could be recouped—a key demand by the ARRL as a prerequisite for their becoming the national ham radio exam coordinator. In other words, neither the actual volunteer examiner can be compensated nor may the VEC seek to defray expenses. As thing stand now, all costs including printing of tests must be borne by the volunteer examiners themselves.

This action does not in any way change the procedures recently adopted for the use of volunteers in the preparation and administration of examinations for the Novice Class of Amateur Radio Operator License-PR Docket 82-727. The new Volunteer Examiner Program (PR Docket 83-27) Report and Order which covers Technician through Extra--Class has not yet been released by the Commission. This will take about two weeks and we anticipate doing a complete wrap up on the program in our next newsletter- including a recap of the new Part 97 rules.

ARRL-INTERVIEWED--VOLUNTEER EXAMS

The first person I called after I got the word from the FCC about volunteer testing being approved was Dave Summer (K1ZZ), General Manager of the ARRL. I wanted to get his reaction to the rulemaking.

(<u>Fred/W5YI</u>)- It appears that the regional VEC concept more or less precludes the ARRL from becoming the nationwide coordinator for ham radio testing...

(<u>Dave/K1ZZ</u>) - Actually that is not the case. What they have done is... to broaden the potential Examinator Coordinators in the event ARRL chose not to play. We asked a specific question at the meeting, "Does that mean we would have to negotiate 13 separate (VEC) agreements for 13 regions and the answer to that was 'No, we would not.'" The Commission did not want to be bound to dealing only with organizations that were capable of providing national coordination. They wanted to expand the universe of potentially available VEC's to include organizations that might only be able to do it on a call area basis. ... The problems associated with a regional approach are not dramatically different from the problems associated with doing it at the national You don't really gain anything by trying to do it on a regional basis. My feeling, speaking as ARRL General Manager, is that the national approach is still the more workable of the two. (WSYI) - Will the League contest the regional VEC approach with a Petition for Reconsideration?

(K1ZZ)- That depends on what the Report and Order says. Our understanding is that negotiating a single agreement covering the national level is not precluded by the Commission's action. If this is the case, we certainly would not see any problem...

(W5YI)- Do you feel that the ARRL will become the nationwide VEC? (K1ZZ)- Based on what I understand of the Commission's action yesterday, I don't believe that the FCC's action diminished our interest in it. We do have an obstacle to be overcome with respect to expense reimbursement but I believe that we are going to overcome that obstacle. It is not insurmountable.

ARRL INTERVIEWS -- VOLUNTEER EXAM (Cont.)

(W5YI)- My understanding is that the FCC is not going to allow VEC's to defray costs of the volunteer testing program. The ARRL comments specifically demanded this as a prerequisite for their VEC participation.

(K1ZZ)- Our feeling was that for this to be a viable program there would have to be some mechanism for recouping the expenses of the program in order for it to work regardless of who does the coordination. This rulemaking really did not address the issue of expense recoupment. That is not to say that there are not efforts underway to get around that particular obstacle and in fact, efforts are under way and we have Commission support for this effort.

(Editor's Note:) The Minutes of the ARRL Executive Committee meeting held at League headquarters on September 10th read: "Counsel Imlay reported on recent discussions with FCC staff concerning the specific legislation the Commission would support to enable volunteer examiner coordinators to be reimbursed for out-of-pocket expenses. ...it was unanimously voted... to proceed with the drafting and introduction of enabling legislation to permit FCC to authorize volunteer examiner coordinators to recoup reasonable expenses incurred in program administration.")

(W5YI)- Do you feel that amateur radio clubs and/or hamfests would be willing to underwrite the expense of amateur exams?
(K1ZZ)- I am sure that at the local level there is a general willingness on the part of the amateur community to absorb some expenses connected with the program. A hamfest committee would have to be crazy not to be willing to absorb the incidental expenses associated with having exams given at their hamfest. That has got to be one of the best drawing cards for attendance that they can have.
(W5YI)- Is the ARRL still interested in becoming the national coordinator for amateur radio examinations?

(<u>K1ZZ</u>)- Definitely! We haven't seem the document yet, but based on our present understanding of what the Report and Order says, the answer is 'Yes!'.

(W5YI)- How would the ARRL go about appointing or selecting regional VEC's in each call district? Would they do this?

(K1ZZ)- It would be speculative for me to comment on that. It is not clear at the moment that that would be necessary. We have only been aware of the regional VEC concept for 24 hours. (W5YI)- What do you think about the requirement that all code exams plus Advanced and Extra class theory be administered by Extra Class

licensees only and the Tech/General theory by Advanced Class holders? (K1ZZ)- That is permitted by under public Law 97-259. The initial program plans that we drew up here were a little bit tighter. Our initial reaction is that this is not going to create a problem. (W5YI)- Do you feel that any group or individual other than an ARRL

entity will come forward and volunteer to be a regional VEC? How would the League handle this?

(K1ZZ)- I certainly would not rule out the possibility. It is more of a question of how would the Commission handle it. We certainly are prepared for that eventuality. We are not approaching this on the basis that it has to be exclusively ARRL or we don't play.

(W5YI)- What do you see as an implementation date for the ham community assuming amateur radio examinations.

(K1ZZ) - We will be trying to resolve the situation as soon as

possible once the Report and Order is actually out. We certainly will be working to respond to it. If I were to guess, I'd say around the first of the year, and that is for the Technician-General. Different classes would be implemented at different times. Advance and Extra would follow somewhat later.

(W5YI)- There have been those that have said that if the ARRL became the national VEC, that this would give them an unfair study material publishing advantage.

(K1ZZ)- Based on a transcript of the Commission meeting yesterday, I think that that point was addressed within the Report and Order. There will be a 'chinese wall' built between two separate sets of personnel that get involved in the exam coordination and these involved in the exam coordination of study material in order to avoid the appearance of an unfair access to information.

(W5YI)- Is the League as interested in selling study materials as it is in being a VEC?

(K1ZZ)- I don't think I would use the kind of emphasis that you used. We have always been interested in the educational aspect of amateur radio. We certainly intend to continue in that area because it is part of our charter. I wouldn't tie the two together that closely. (W5YI)- Is it conceivable that the League might recommend other than ARRL originated study materials?

(K1ZZ)- That is an interesting question. I guess in fairness, I couldn't rule out the possibility. What we are trying to do is to strive to provide first class study material to prospective amateurs. We have found that most effective way of doing that is to publish it ourselves. Certainly, if we were to come across a text that seems to respond particularly well in a particular area, we would not hesitate to recommend it. I think you will find cases where that has occurred in the past.

(W5YI)- In order to eliminate any question of conflict of interest is it possible that the ARRL might publish study materials and make them available on a 'cost basis?'

(K1ZZ)- The problem that we have run into there is more of a question of competitive advantage. Putting myself in the shoes of a commercial publisher, I would much rather compete with material that is being supplied with a price tag that is more like what I would have to charge someone that provides it at cost. We keep the cost of our published materials low largely by volume. The people in the field giving the exam will have no conncetion with the production of study material.

OCTOBER MEMBERSHIP MEETING

Lloyd Phelps WD5HEH has recommended certain changes in the By-Laws and has reviewed them with the Board of Directors. The Board agreed the changes should be made and ordered that they be placed before the membership at the October meeting for consideration and action.

Following are the revised sections of the By-Laws to be considered and acted upon at that meeting. Comparison of these amended wordings with the current By-Laws will show the detailed changes proposed:

ARTICLE I - MEMBERSHIP

Section A.2. Family membership, when more than one member of a family is living at a single address.

Section D.3. Non-payment of annual dues by due date.

ARTICLE VI - DUES

Section A.2. Family membership Eight Dollars (\$8.00), plus Two Dollars (\$2.00) for each additional family member.

Section C. Annul dues are due January 1 of each year but may be paid in advance on a one year basis. Non-payment of annual dues by due date shall result in termination of membership.

Following the close of the business portion of the meeting, we'll have Marty Stebbins W4WUI, a well-known member of the Channel 11 KHOU news team and a ham for 27 years, will recount some of his adventures and misadventures along the way. Marty does a great job on camera and we can look forward to an enjoyable talk.

MINUTES OF MEETING OF MEMORIAL EMERGENCY RADIO ASSOCIATION ON SEPT. 6, 1983

Tom Casey WA5ACF reported that the frequency coordinator had assigned the 144.65/145.25 pair to us and said it probably would be about 6 months before we might have another pair assignable in lieu of it.

Bob Spradling W5UBD reported that we have about \$500 in the treasury. Tom WA5ACF suggested that we issue certificates of appreciation to contributors of \$25 or more to the MERA repeater fund. He said he also would get the paper on which the certificates could be printed. Harold Parker ND5F reported on the antenna project. We will build about 120 "J" antennas to sell for about \$7.95 each. It was suggested that we take a donation rather than make an outright sale.

Bill Bates KA5FWF has loaned us a transceiver to serve as a temporary repeater. It was damaged during Hurricane Alicia and we will have it repaired.

The loaned repeater from Corsicana will be put on the ASAP. Tom WA5ACF will get crystals for it, costing about \$50. He will change the selenium rectifiers to silicon rectifiers. Duplexers will come from WACOM and will cost about \$600. Tom WA5ACF has an ID board and a control board, donated by Jim Arnold W5RNK.

Two important facts about the MERA repeater should be kept in mind: The first is that it is NOT a Brazos Valley Amateur Radio Club (B-VARC) machine; it IS a Memorial Emergency Radio Association (MERA) repeater and should not be called the "B-VARC repeater." And second, although the performance of the present temporary equipment does not equal that of the 4.85/5.45 machine, the MERA repeater -- 144.65/145.25 -- has good coverage in the southwest area, and not only MERA but also B-VARC members are urged to use it whenever possible in order to demonstrate to the Frequency Coordinator the need for the repeater in this area, and thereby stay on the top of his list of applicants for repeater pairs.

Another funding activity for the MERA repeater is the construction of twin-lead "J" antennas for sale at the ARRL Convention flea market. These antennas are very broad-banded, have excellent gain, and can be used to good advantage by travelers, fixed station operators, and in emergency conditions. Come by the flea market table and get one -- you'll be glad you did!



Broadcast on Channel 11 News on August 23, 1985
